# A MESSAGE FROM THE PRESIDENT

This was a difficult year for Ottawa. Covid-19 has impacted the livelihood of Ottawa's most vulnerable. Parents who were already living off low-income wages are now struggling even more to make ends meet. Seniors have been isolated from their loved ones to try and stay healthy. People have been put out of work, children have faced numerous setbacks and hardships, and community resources/government supports have been stretched thin city-wide to try and compensate for the pandemic's effects.

We are proud to say that the Caring and Sharing Exchange made a difference in the lives of those in need of relief and dignity. In fact, through both the Christmas Exchange and Sharing in Student Success Programs, assistance was provided to everyone on our lists!

Through the Sharing in Student Success Program, we provided assistance to all 3,020 children from families in need that were registered for the program. This assistance not only eased the tension on already extremely tight family budgets, but also allowed these children to return to school with a sense of normalcy and on an equal footing with their peers. Through the Christmas Exchange Program, we provided 19,149 individuals in need the means to enjoy a festive holiday meal that otherwise would not have been possible.

For 106 years the Coordination Service has made our assistance programs more efficient and effective by eliminating any duplication of service across the community. This year, the service saved the community \$120,985, an increase of 49.5% over the previous year. Through this innovative service, the C&SE ensures that donor dollars go further, with all savings reinvested to help even more people in need.

None of this would be possible without the incredible support of our committed volunteers and generous donors. In addition, I am amazed year after year by what our CS&E team is able to accomplish. The small but mighty team works tirelessly and with such an amazing passion and the resulting impact on our community speaks for itself.

It has been an absolute pleasure to have led a committed group of Board Directors over the past year. This year, we say goodbye to Anis Hanna ( joined the Board in 2017 and was elected to the role of Vice President in 2018), Sana Qureshi (joined Board in 2018) and Amanda Bennett (joined Board in 2019). Thank you, Anis, Sana and Amanda it has been a pleasure to work with you over the last several years.

# THE EXECUTIVE DIRECTOR'S REPORT

This was a year of transition and innovation for the Caring & Sharing Exchange (C&SE). The Covid-19 pandemic and the subsequent quarantine that was put in place in March of 2020 had staff working from home. As a result, the decision was made to move to a remote work environment permanently and by doing so, realizing a significant cost savings. Due to pandemic safety regulations, several festivals and events held to raise funds for our programs needed to be cancelled or reimagined. In fact, we had to do the same with our own initiatives, including Running on Empties, Corporate Hamper Packing Day, and our Backpack Stuffing Day. However, through our fundraising efforts, including several new partnerships, we had a very successful year.

Through our Christmas Exchange (CE) and Sharing in Student Success (SISS) programs, we were again able to provide dignity, relief, and hope to 22,169 Ottawa individuals in need, while ensuring that our dollars continued to go further through our innovative coordination service. We are very excited to report that through both assistance programs, we helped everyone on our list and were left with no waiting list.

Thanks to generous individuals, groups, and businesses across Ottawa, we saw a 43% increase in in-kind donors willing to provide families with festive food hampers through our Sponsor-a-Hamper program.

Kindness Week in Ottawa was celebrated online-only this year. Rabbi Reuven Bulka, co-founder of Kind Ottawa, was unfortunately unable to participate in this year's events due to illness. In his honour, we promoted the Rabbi Bulka Kindness Project (rabbibulka.com). While we could not present deserving citizens with kindness awards this year, we were still able to promote kindness across the capital through online initiatives. We shared stories of kindness sent in from Ottawa citizens and hosted a virtual Art Show, featuring kindness themed artworks submitted by local artists. We launched the week with a Kindness Video, featuring prominent figures in Ottawa who spoke on kindness and Rabbi Bulka's influence.

I want to thank our dedicated Board of Directors, our donors, our partner agencies, the staff, and the incredible volunteers that help us provide assistance to those in need. You made it possible for us to have such a successful year, despite all the challenges faced. We could not do it without you!

## PROGRAMS REPORT



#### THE CHRISTMAS EXCHANGE



Due to the Covid-19 pandemic, households were not able to gather this year at Christmas. On top of this, many families who were already struggling to make ends meet were experiencing income loss due to province wide lockdowns. As it has been done for over a century, the Caring and Sharing Exchange continued its tradition of mitigating the suffering of individuals and families in need through the holidays by providing them with means to enjoy a warm, homemade meal.

In 2020, we were unable to hold our annual Hamper Packing Day (which typically supplies 400 families with food hampers) and many of our other fundraising initiatives were either cancelled, or had to be altered, to abide to pandemic safety regulations. However, despite these set backs and thanks to the generous

contributions made by our supporters and donors, we helped every person who requested Christmas assistance. We provided the 19,149 individuals with either a food hamper containing all the fixings for a festive Christmas dinner, or with a redeemable gift voucher to so they can purchase their own food items.

#### SHARING IN STUDENT SUCCESS



In 2020, the Caring & Sharing Exchange (C&SE) was able to provide back-toschool assistance to every child on our list. The C&SE provided 3,020 students with a backpack full of grade appropriate school supplies so they could return to school on equal footing with their peers.

As well, 370 children received assistance thanks to partnering agencies. Through our Coordination Service, 250 applicants were determined to be duplicates, receiving assistance elsewhere in the city. We are beyond grateful for our volunteers and dedicated donors who supported this program so that children in need could be prepared to succeed.

We are also very thankful for our retail partners, who help us maximize donor dollars so that we can purchase three backpacks for the price of one.

l thank you, so much, for the backpacks you provided for my children. Their faces lit up when they saw all the new supplies they get to use this year.

#### THE COORDINATION SERVICE



Over the past five years, our Coordination Service has saved organizations across Ottawa almost \$800,000. Those community dollars were re-invested into back-to-school and holiday food assistance programs to help even more people. We are so thankful to our 250+ agency partners that continue to partner with us, improving the efficiency of our assistance programs city wide.

#### KINDNESS WEEK



Kindness Week 2021 ran from February 12–19 in Ottawa, but this year's events took place virtually with some adjustments. Firstly, Kindness Week Chair and Co-Founder of Kind Ottawa, Rabbi Reuven Bulka, fell ill this year and was unfortunately not able to participate in Kindness Week initiatives. As well, due to the risks associated with gathering in person, we could not host our traditional in-person events and did not distribute Kindness Awards to nominees.

Instead, we took to the digital sphere! We launched Kindness Week with a video featuring prominent members of Ottawa speaking about the impact and importance of kindness (see below). We encouraged community members to send in stories of kindness, whether given or received, and posted these stories across our social

media channels and on www.caringandsharing.ca. We also encouraged citizens across Ottawa to submit works of art to us that exemplified what kindness means to them and compiled submissions into a Virtual Art Show video (see below).

In honour of Rabbi Bulka, we also encouraged Kind Ottawa followers to visit rabbibulka.ca and to take part in the Rabbi Bulka Kindness Project by submitting a story of kindness or sharing a story about Rabbi Bulka himself.

## **FUNDRAISING EVENTS**

#### 33rd ANNUAL RUNNING ON EMPTIES FUNDRAISER

Since 1987, the Caring and Sharing Exchange has partnered with the Beer Store to raise funds for the Christmas Exchange program by running a bottle drive. In mid-December, volunteers and community leaders were stationed at over 30 Beer Store locations across Ottawa to collect empties.

This year, due to Covid-19, we were not able to run this event in person. However, the Beer Store generously asked customers to consider donating their empties at various locations across the city in support of the Christmas Exchange program.

Prominent community figures and Caring & Sharing Exchange followers helped spread the word about this event, encouraging everyone to donate their empties in support of our Christmas assistance program. Thanks to many joint efforts, we were able to raise a whopping 14,399.60!

In the last 33 years, the event has raised over \$400,000 and has helped provide thousands of families with much-needed support at Christmas time. Thank you to the Beer Store and our amazing supporters for keeping this event going, even during a global pandemic.



Typically, the Caring & Sharing Exchange invites generous corporate donors and community supporters to gather at the Horticultural Building at Lansdowne to pack and deliver hundreds of festive Christmas food hampers to individuals and families in need within our community. At this event, we also host a silent auction, where attendees can bid on numerous items donated by local businesses. Due to Covid-19 safety regulations, this entire event was cancelled in 2020.

However, we still decided to host a silent auction (as we do annually at our Hamper Packing Day event) online to help raise funds. Thank you to all the wonderful community businesses who donated items to the auction to be sold and to all the participants who placed their bids.

#### **CHRISTMAS CHEER 2020 (VIRTUAL)**

The annual Christmas Cheer breakfast, a fundraising event that supports numerous charities across Ottawa at Christmas time, was held virtually this year on December 4, 2020. Featuring musical guests, inspiring speakers, and special surprises along the way, this event went off without a hitch! We are sincerely thankful for Christmas Cheer, it's partners and supporters, and to the generous attendees who donated during the event.
